## Introduction

Disasters, emergencies, shocks, and stresses associated with natural, technological, and health hazards, climate change, conflict, and violence have destructive impacts on education systems worldwide. These events can restrict access to safe, inclusive, and quality education and lifelong learning opportunities, denying generations the right to education<sup>1</sup> and preventing states from reaching their development goals, notably SDG 4<sup>2</sup>.

Realising the right to education means building and transforming education systems that are resilient and responsive to contemporary challenges, notably the impact of climate change and other emerging risks. It implies focusing on those at the greatest risk of being left behind.

Established in 2013, the Global Alliance for Disaster Risk Reduction and Resilience in the Education Sector ([GADRRRES](#)) is a multi-stakeholder platform composed of UN Agencies, International Non-Governmental Agencies, leading humanitarian and development organisations, and private sector organisations organised at the global level and in some cases at the regional one through Regional Affiliates. GADRRRES advocates for and supports child rights, resilience, and sustainability in the education sector and plays a role in bridging the humanitarian, development, and peace-building triple nexus.

The efforts of members and regional affiliate groups are guided by the Comprehensive School Safety (CSS) Framework as its document and guidance. The CSS Framework 2022-2030, released in September 2022, takes an all-hazards, all-risks approach that provides strategic guidance to duty-bearers and their partners to promote safe, equitable, and continuous access to a quality education for all.



As defined in the ToRs for GADRRRES governance, GADRRRES is pursuing three interrelated and mutually reinforcing core objectives:

1. Strengthen global and regional coordination, capacity development, and collective impact for Comprehensive School Safety.
2. Advocate for Comprehensive School Safety.
3. Improve global knowledge management of information, resources, and evidence for Comprehensive School Safety.

The present GADRRRES 2023-25 Strategy builds on recent developments in the GADRRRES, including the adoption of the CSS Framework 2022-2030 and the enlargement of the Alliance, as well as on the Collective Impact Evaluation of GADRRRES. It intends to operationalise the GADRRRES core objectives into key priorities of action for the next three years, ensuring coherence and complementarity of its activities and maximising the impact of the collective action of its members. The Strategy will be accompanied by an annual work plan detailing activities per priority of action.

# GADRRRES: An Overview

## Mission

The mission of the GADRRRES is to ensure that children and education workers in all learning facilities are safe from all hazards in and on the way to schools, and that schools contribute to building a culture of safety and resilience.

## Vision

GADRRRES' vision, consistent with the objectives of the CSS Framework, is that education sector duty-bearers and their cross-sectoral partners have the evidence, data, guidance and technical support to be able:

- To protect learners, educators and staff from death, injury, violence and harm in schools and other learning spaces.
- To plan for education and protection continuity, and limit disruptions to learning in the face of shocks, stresses, hazards and threats of all kinds.
- To promote knowledge and skills of learners and duty-bearers, to contribute to risk reduction, resilience building, and sustainable development.

## Approach

The efforts of GADRRRES members and Regional Affiliates are guided by the CSS Framework 2022-2030 and support key global agendas:

GADRRRES is informed by an 'all-hazards approach', which is underpinned by two important theories of change that guide its efforts as an Alliance:

- The socio-ecological model, stressing the linkages between child, family, school, community, and the larger society.
- The Collective Impact Approach, which requires multi-stakeholder engagement in pursuing a common agenda, agreed-upon measures of success, facilitation of mutually reinforcing activities and constant communication.

# **GADRRRES 2023-2025 Strategy**

**GADRRRES Core Objective 1**  
**Strengthen global and regional coordination, capacity development, and collective impact for Comprehensive School Safety**



GADRRRES ambitions to facilitate collaboration, maximise synergies and support coordination of the work of members of the Alliance and other stakeholders in research, practice, and policy, contributing to strengthening the humanitarian, development and peace-building triple nexus. GADRRRES also intends to promote networking and partnership-building to facilitate the mainstreaming of Comprehensive School Safety into national education policies and sector plans, and ensure complementarity, coherence and work relations.

### **Priorities of action for 2023-2025:**

- Build GADRRRES global and regional membership.
- Foster and develop school safety-related dialogue and collaboration by increasing engagement within GADRRRES.
- Coordinate with existing global education clusters/working groups/coordinated efforts and strengthen intersectoral collaboration (incl., GCPEA, Geneva Global Hub for EIE, Greening Education Partnership, Global Education Cluster, Anticipatory Action Hub, etc.) while operating in the framework of the humanitarian, development and peace-building triple nexus to help leverage political action to favour school safety.
- Support existing Regional Affiliates (i.e., Asia Pacific Coalition for School Safety (APCSS) and Regional Education Group for Latin America and the Caribbean (GRE-LAC)).
- Support the development of new Regional Affiliates on the model of the APCSS and GRE-LAC or help expand the work of existing coordination education groups.
- Develop training materials to introduce the CSS Framework 2022-2030 and provide guidance on its implementation to build and strengthen the capacity of duty bearers, practitioners and other stakeholders.
- Hold global and regional events to promote the CSS Targets & Indicators and the CSS Operational Guidance Catalogue, best practices, case studies & other research.

### **Expected Outcomes by 2025:**

- At least 5 new GADRRRES global members (2 in 2023).
- At least 3 new GADRRRES partners (2 in 2023).
- At least 2 new Regional Affiliates or expanding the work of existing coordination education groups (1 in 2023).
- Participation of GADRRRES in activities at global and regional levels (incl., webinars, training) (annually).
- Existing regional school safety networks developed and strengthened.
- Training materials developed, adapted and adopted in 3 regions (2024).



**GADRRRES Core Objective 2:  
Advocate for Comprehensive School Safety**





On the occasion of the launch of the CSS Framework 2022-2030, GADRRRES is developing a common strategy for evidence-based advocacy on school safety. The Alliance is committed to undertaking high-level advocacy efforts to promote school safety at global and regional levels – in some cases at national level - among the education, disaster management and child protection sectors with the aim to make Comprehensive School Safety a priority central to agencies’ agendas and other relevant coordination mechanisms and platforms.

### **Priorities of action for 2023-2025:**

- Build awareness for the CSS Framework 2022-2030 through high-level global, regional and national launch webinars and events to contribute to creating a network of stakeholders working on school safety.
- Support socialisation of the CSS Framework 2022-2030 through tailored strategies considering different stakeholders and levels (i.e., global, regional, subregional and national).
- Adopt and implement the CSS Framework 2022-2030 advocacy strategy.

### **Expected Outcomes by 2025:**

- Implementation of the CSS Framework 2022-2030 advocacy strategy (2023).
- Organisation and contribution to events/advocacy and communication campaigns promoting the CSS Framework 2022-2030 (annually).



**GADRRRES Core Objective 3:  
Improve global knowledge management of information,  
resources, and evidence for Comprehensive School  
Safety**



GADRRRES is committed to facilitating the collection and dissemination of existing and new knowledge, educational and training materials, guidelines and standards on safer learning facilities, school safety and educational continuity management, as well as risk reduction and resilience education. GADRRRES also aims to provide evidence-based CSS guidance to address specific gaps in the implementation of the CSS Framework 2022-2030.

### **Priorities of action for 2023-2025:**

- Translate and disseminate the CSS Framework 2022-2030 and CSS Targets & Indicators in various languages.
- Develop and implement CSS Assessment Suite tools and methods.
- Assess and document CSS policy progress globally including data on its use and implementation, to monitor progress toward school safety, and strengthen the evidence foundations for action.
- Develop and maintain the CSS Operational Guidance Catalogue, which will elaborate on each of the four CSS components (incl. Enabling Systems and Policies; Safer Learning Facilities; School Safety and Educational Continuity Management; and Risk Reduction and Resilience Education).
- Develop a collective knowledge management strategy for school safety and education in emergencies with interested partners (e.g., INEE, UNESCO, Geneva Global Hub for EiE and donors).
- Encourage development of the CSS Framework 2022-2030 evidence base through operational and contextualised research.

### **Expected Outcomes by 2025:**

- Publication of the CSS Framework 2022-2030 & Targets & Indicators into 10 languages. The translations are made available on the GADRRRES website and PreventionWeb (8 in 2023).
- Revision and deployment of the Global CSS Policy Survey in at least 50 countries through a digitized, and reusable toolset and methodology for periodic collection, reporting and change analysis.
- Publication and dissemination of reports analysing the global and regional impacts of the CSS Framework implementation (2024).
- Redesign and update of the GADRRRES Website to promote the CSS Framework and its implementation, and support GADRRRES transparency and growth.



## Implementation Modalities

The implementation of GADRRRES 2023-25 Strategy will build on the strengths of GADRRRES members and its experience working to strengthen the resilience of education systems at the global and regional levels.

The achievement of its objectives will be pursued through the aforementioned actions and supported by the following implementation modalities:

### Coordination

#### Internal

GADRRRES brings together staff and experts from recognised organisations to develop and promote school safety through the CSS Framework 2022-2030 and CSS Targets and Indicators, as well as through collective publications and activities globally and regionally.

Between 2018 and 2022, the GADRRRES expanded, welcoming six new members to reach eighteen international members and two Regional Affiliates as of December 2022.

GADRRRES will build on its interdisciplinary technical membership, the diversity of the mandates of its member organisations as well as on its global and regional levels of action to achieve results in areas of shared priority and build on past experiences of collaboration. GADRRRES will count on a series of initiatives to strengthen collaboration and coordination including the revision of its working structure and elaboration of an annual work plan, the revision of the GADRRRES membership process in implementing modalities, the publication of an internal newsletter, the production of an annual report to share progress, induction processes for new members/focal points, technical backstopping to Regional Affiliates and evaluation of the current internal capacity. These activities are undertaken by the GADRRRES Chair and Secretariat and achieved in close collaboration with the GADRRRES global members and Regional Affiliates.

#### External

Strengthening GADRRRES external facing in terms of communication, advocacy and stakeholder support will be a priority for the Alliance over the period 2023-25.

GADRRRES is committed to strengthening coordination with other global stakeholders/platforms. At the global level, this includes notably the identification within its member organisations, of the focal points in existing mechanisms, platforms and alliances (e.g., INEE, GCPEA, Geneva Global Hub for EiE) in order to strengthen the linkages, avoid duplication of initiatives and promote the school safety agenda, as well as by inviting those stakeholders to school safety and education related events and/or participating in initiatives organised by them (e.g., ongoing revision of the INEE Minimum Standards). At the regional level, GADRRRES will also encourage coordination efforts by supporting existing Regional Affiliates and the development of new regional alliances. Those will connect to the national level coordination mechanisms.

## Advocacy

Advocacy plays a key role to disseminate information on the work undertaken in the area of school safety and support Member States in realising their commitments in this field.

GADRRRES will focus its advocacy efforts in:

- Making available materials to support each GADRRRES member organisation and Regional Affiliates in their internal advocacy process introducing GADRRRES and the CSS Framework 2022-2030.
- Promoting its role and action in school safety and delivering effective advocacy through various communication outlets (incl., the Safe Children, Safe Schools Community of Practice).

## Knowledge and Information Management

Knowledge and Information Management (KIM) is essential to capture, map and share school safety-related practices as well as to build a contact database including relevant stakeholders in ongoing communications. Its development will integrate two interlinked priorities to increase knowledge sharing, collaboration and communication visibility:

- Collaboration across development/humanitarian actors to improve Evidence / Learning / Knowledge Management and facilitate access to information and enhance knowledge sharing. Discussions intend to be notably held with INEE to reflect upon knowledge management synergies to avoid duplication of efforts.
- Use of a Customer Relationship Management (CRM) system to manage interactions with existing and potential GADRRRES audiences.

## Resource Mobilisation

Resource mobilisation will be collectively and strategically addressed by GADRRRES to advance the objectives of the CSS Framework 2022-2030.

GADRRRES will also advocate for the full integration of risk reduction and resilience as a strategic priority for multilateral education funds, and vice versa, the targeting of the education sector for multilateral climate/disaster risk reduction funds.

## Monitoring and evaluation

In terms of monitoring and evaluation, GADRRRES will commit to:

- Make CSS Assessment Suite and other available tools\* and guidance to Education Authorities for integration into enriched Education Management Information Systems for use in ongoing planning and decision-making for school safety. \*This includes deterministic and probabilistic tools, technical and non-technical tools, pre- and post-disaster tools, and the methodologies and guidance for scalable and sustainable use, and capacity building for their use, maintenance and upgrading.
- Regularly review and report on progress made toward the priorities of the strategy. This will be done by analysing the progress made in the implementation of the work plan – that is guiding the implementation of the strategy. This will be undertaken quarterly by the GADRRRES Secretariat in collaboration with the Working Groups co-leads to the Steering Committee Group and twice a year to the entire groups and publicly via the GADRRRES newsletter, the SCSS Community of Practice and other communication channels.
- Create and implement an annual and internal feedback system on field experience to collect information on the CSS Framework 2022-2030 implementation. This will particularly aim to strengthen the socialisation and implementation of the CSS Framework 2022-2030.
