Developed by the Global Alliance for Disaster Risk Reduction and Resilience in the Education Sector (GADRRRES), the CSSF 2022-2030 supports education sector policymakers, planners, school administrators, and their partners to promote child rights, sustainability, and resilience in the education sector. The framework takes an "all-hazards" approach, including, natural and climate change-induced hazards, technological hazards, biological and health hazards, conflict and violence, as well as everyday dangers and threats. It recognizes the need for full inclusion of children marginalized by age, gender, disability, language, and socio-cultural factors as well as location and poverty. It supports access, quality, and management strategies in the education sector. Initially developed in 2012 following two decades of school safety advocacy work, the CSSF was revised in 2022 in the context of a global pandemic, and a growing understanding of the multiple threats of climate, conflict, and displacement. The interconnectedness of these risks leads us to the imperative of an all-hazards, all-vulnerabilities, all-risks approach.
