

Safe Children, Safe Schools Community Terms of Reference

Background

The Global Alliance for Disaster Risk Reduction and Resilience in the Education Sector (GADRRRES) established the **Safe Children**, **Safe Schools Community of Practice** (CoP) as a strategy to engage the widest range of individuals and organisations with news, information, research and resources, to develop knowledge, strategies, and policy and program impacts for child-centred risk reduction (CCRR) and school safety (SS).

Objective

To create a robust and enduring mechanism through which all researchers, practitioners, policy makers and other interested stakeholders working on CCRR and SS can actively collaborate on and contribute to the following goals:

- To ensure children's safety, security, protection, and well-being in relation to all types of hazards and risks, in and on the way to school and other learning environments
- To reduce inequities in access to education and to ensure educational continuity in the face of hazards and risks
- To safeguard education sector investments and assets
- To promote a culture of safety and resilience

Values

We value the following:

- **Diverse Membership:** encourage membership from different sectors and disciplines.
- **Knowledge management:** identify, collate, and distribute new knowledge on CCRR and SS, including experience and research.
- Capacity Development and Learning: develop and share capacity development opportunities for members and other stakeholders
- **Innovation:** support the dissemination of new ideas and resources.

• Collective impact: strengthen our common agenda and develop and endorse shared measures and standards, to encourage mutually reinforcing activities, and to maintain regular communications to build trust, and to work more collaboratively to the same ends.

Ground Rules

We operationalise our values with the following rules:

- 1. Members are willing to share challenges, and lessons learned as well as successes.
- 2. Members strive to create an environment of trust and to foster insightful, non-threatening discussion of ideas and experiences.
- 3. Membership and topics reflect the objective of the CoP.
- 4. Members agree to be respectful and to listen and respond to each other with open and constructive minds.
- 5. Members will not be afraid to respectfully challenge one another by asking questions, but refrain from personal attacks -- focus on ideas.
- 6. Members are encouraged to participate -- community growth depends on the inclusion of every individual voice.
- 7. Just listening is OK too we respect that people have different styles of membership.
- 8. Members commit to seek opportunities for consensus, compromise and creative solutions.
- 9. Members will contribute to an atmosphere of problem solving rather than rigid position-taking.
- 10. Members will attempt to build on each other's strengths and help support and broaden each other's understanding.

Operating principles

- 1. The language of the CoP will be English (we hope to expand this).
- 2. The CoP will be moderated to maintain quality, decorum, and adherence to the objective, operating principles and ground rules.
- 3. GADRRES member focal points are expected to contribute regularly to the community, sharing information about upcoming and recent meetings, events, trainings, research, publications, programs, and other news.
- 4. Individual members are similarly invited to share as well as to initiate discussions and pose questions to the group.
- 5. Members can manage the frequency they receive CoP updates (via the homepage).
- 6. Views expressed are those of individuals and/or organisation they represent.

Membership

Membership is open to anyone who shares our objective and values and is willing to observe the ground rules. Individual practitioners, policymakers, advocates, influencers, academicians, researchers, teachers, and students are invited to participate.

Results Overview

To accomplish this objective, the CoP will achieve three results.

- Create an online mechanism for the community that enables members to share knowledge and expertise, expand each other's network of contacts, explore creative solutions to common problems, and develop an understanding of CCRR and SS programming and policy development and implementation and best evidence-based practices.
- 2. Facilitate collaborative sharing and learning about CCRR and SS programming, policy development and implementation, and best practices through a variety of interactive community activities that collectively support meaningful, productive interactions among members.
- 3. Develop an online bibliography on Zotero and a resource collection on PreventionWeb that will become a comprehensive repository of contributions from CoP members and others.

Result I: Create an online mechanism for the community

The online community platform is hosted by PreventionWeb at https://cc.preventionweb.net/scss The community platform is primarily email-based (scss@cc.preventionweb.net) with the option to also log into the community webpage.

It provides the key functionalities we seek, such as discussion through email or an option to log into the website and contribute, community member profiles, archives, the ability to schedule tasks and create sub-communities and a searchable library (or the opportunity to link directly to PreventionWeb collections), and it is free of charge.

Result 2: Facilitate collaborative sharing and learning

The CoP will provide a structured forum for members to share knowledge and learn in a collaborative manner.

Regular communications and community activities will help gain buy-in from members and maintain their interests throughout the life of the CoP. Community members will be encouraged to fulfil participation requirements as part of their commitment to the CoP objectives, recognising that in any community there will be a range of frequency of participation. We will collect participation data and responses from members as these activities progress and adjust our expectations accordingly.

While we understand that many people like to be engaged in CoPs to access knowledge and not necessarily actively participate, we have set some guidance for community members who would like to be active. Any level of participation is warmly welcomed.

 1 The list of topics for discussion boards, will be developed from member surveys and discussions with CoP advisors. Members will be encouraged to suggest topics on an ongoing basis.

Facilitator activities will help to animate the community and stimulate discussion. During the CoP's early stages the facilitator will also feed discussions when needed, connect members who have intersecting activities, and identify highly active members to encourage them to take on leadership roles within the community.

Result 3: Develop a resource collection on PreventionWeb and an online bibliography on Zotero

The CoP Facilitators will lead the development of a resource collection on PreventionWeb to serve as a comprehensive, searchable repository of research, guidance and tools focused on CCRR and SS, populated with contributions from CoP members. CoP members will be encouraged to upload contributions on a regular basis.

In addition, CoP Facilitators will lead on the development of a freely available online crowd-sourced bibliography of CCRR and SS research. This is already underway at https://www.zotero.org/groups/1857446/ccrr_css? Members will be encouraged to continually populate this with the latest research.

Sustainability

While interest in child-centred risk reduction (CCRR), school safety (SS) and related research have increased over the past 10-15 years, there are significant gaps in both research utilisation, and in practice-based research. Guidance materials and tools to support the use of research are both underdeveloped and untested, and monitoring and evaluation of CCRR and SS program impacts remain inadequate. Lack of communication and collaboration hinder our progress in an area that has many strong and capable advocates. While there have been sporadic efforts to launch and maintain online CoPs, and plenty of interest from practitioners (NGOs), academics, governments and other stakeholders, these have not been resourced or able to follow best-practices in launching and sustaining a vibrant CoP.

Save the Children will provide the initial support and facilitation to the CoP with support from C&A and the C&A Foundation until at least June 2020, to be reviewed in the first quarter of 2020. The CoP facilitation team include:

Marla Petal - Sponsor

Provides domain expertise and supports thought leadership contributions.

Kate McFarlane – Facilitator / Moderator

Moderates contributions, manages CoP implementation activities, facilitates and supports CoP contributions and facilitates discussions.

Elizabeth Wilke - Coordinator

Manages CoP homepage, membership and IT (working with PreventionWeb) as well as supports facilitator in moderation.

Because the CoP's developmental phase will require more time, we estimate that this will require a time commitment of 15 to 20 hours per week (between the team) during the CoP's first two to three quarters and reduce to 10 to 15 hours per month once the community's foundation has been established. The facilitator and coordinator will coordinate with PreventionWeb to handle any technical and usability issues.

Communications and Roll Out

An initial roll out plan for the CoP is included below. By late 2019, a more detailed communications plan will be developed to support the uptake of the CoP by its members as well as to publicise success stories from the CoP to attract new members and promote community growth.

Terminology

Whilst GADRRRES has used the phrases *Comprehensive* School Safety (CSS) and *disaster* risk reduction (DRR) which are familiar to a wide audience of academics and practitioners, these terms have left behind a wider audience that shares the same concerns but has felt that "comprehensive" didn't include conflict and interpersonal violence, and that "disasters" overlooked the smaller scale and the everyday hazards that don't seem to overwhelm local ability to respond or cope (for example, drownings, road accidents, regular monsoon rains, slower-onset and invisible hazards such as coastal erosion, air pollution) that similarly threaten children's safety and equitable access to education. Instead we are emphasising here a responsiveness to *all* the hazards and risks that impact children in and on the way to school (as well as at home and in their communities). We have dropped the words "comprehensive" and "disaster" in the interests of inclusivity.
